Todd L. He serves as Vice President and Corporate Counsel for The Economic Club of Las Vegas. He served as Chairman on the Las Vegas Planning Commission and serves on the executive board of the Las Vegas Area Council. He also serves as the Vice President of High Adventure & Career Programs on the Western Region Executive Board for the Boy Scouts of America. He previously served on the Interfaith Council of Southern Nevada, and directed public affairs while acting as spokesman for his church in Southern Nevada. He currently serves on the City of Las Vegas Historic Preservation Commission. In his spare time, Todd enjoys spending time with his family, biking, and hiking.
